

Terms of Use for Individual Members of the PROTEC17 Member Portal

Thank you for being part of the PROTEC17 community! As stated in our mission: We are a member-powered union inspiring action, advancing equity, and building community. To move this mission forward, we have created an online portal for members which includes online discussion boards, forums, and communities. The goal is to have an accessible, connected, secure, and trustworthy place where members can exchange ideas and information, collaborate, and move towards action.

The portal is designed to encourage the lively exchange of ideas and opinions while protecting our union values of respect, dignity and solidarity. These terms of use are written to enshrine those values and will govern your access to, and use of, the portal [members.protec17.org]. Civil dialogue is our priority.

Acceptance of the Terms of Use

These terms of use are entered into by and between You and PROTEC17. The following terms and conditions, together with any documents they expressly incorporate by reference (collectively, “Terms of Use”), govern your access to and use of [members.protec17.org], (the “Website”) including any content, functionality, and services offered on or through the website.

By using the Website, you accept and agree to be bound and abide by these Terms of Use and our Privacy Policy (<https://members.protec17.org/privacy-policy/>), incorporated herein by reference. If you do not agree to these Terms of Use or the Privacy Policy, you may not access or use the Website. We reserve the right to suspend access to the Website to anyone who violates these Terms of Use.

The Website may contain message boards, chat rooms, personal web pages or profiles, forums, bulletin boards, discussion groups, and other interactive features (collectively, “Interactive

Services") that allow users to post, submit, publish, display or transmit to other users or other persons (hereinafter, "post") content or materials (collectively, "User Contributions") on or through the Website. All User Contributions must comply with the rules set out in these Terms of Use.

You agree that you will:

- Treat all members and colleagues fairly and equally.
- Stimulate conversation, be respectful of others' views, and refrain from personal attacks.
- Respect legitimate intellectual property rights, do not plagiarize work, and give credit to the originators of ideas.
- Don't share the posts of others without permission.

You understand and acknowledge that you are responsible for any User Contributions you submit or contribute, and you, not PROTEC17, have full responsibility for such content, including its legality, reliability, accuracy, and appropriateness. We are not responsible or liable to any third party for the content or accuracy of any User Contributions posted by you or any other user of the Website.

Discussion Group Etiquette

PROTEC17 strives to create and maintain a community in which people of many different backgrounds and cultures are treated with respect. Please carefully read the items listed in the disclaimer and legal rules below.

By accessing and using the discussion groups, you agree to:

- Be mindful and respectful of others' linguistic backgrounds – while the language for online discussions is mostly English (unless otherwise specified), remember not everybody is a native English speaker/writer.
- Keep subject lines concise and clear so that members can respond appropriately and easily search the archives.

- Include only relevant portions of the original message in replies.
- Only send a message to the entire list if everyone can benefit from it. Do not send “thank you” and “me too” replies to the full list.
- Avoid administrative messages, such as remove me from the list (use the web interface to change your personal settings).
- If relevant, add “Long Message” to the subject line or at the beginning of the message body.
- Not spam several groups or forums with the same message.
- Not publicly post commercial messages.
- Use caution when discussing products. Information posted in groups or forums is available for all members to see. Comments are subject to libel, slander, and antitrust laws.

Content Standards

You may use the Website only for lawful purposes and in accordance with these Terms of Use. These standards apply to any and all User Contributions and use of Interactive Services. User Contributions must in their entirety comply with all applicable federal, state, local, and international laws and regulations.

User Contributions must not:

- Contain any material that is defamatory, obscene, indecent, abusive, offensive, harassing, violent, hateful, inflammatory, or otherwise objectionable.
- Promote sexually explicit or pornographic material, violence, or discrimination based on race, sex, religion, nationality, disability, sexual orientation, gender identity, or age.
- Infringe any patent, trademark, trade secret, copyright, or other intellectual property or other rights of any other person.
- Violate the legal rights (including the rights of publicity and privacy) of others or contain any material that could give rise to any civil or criminal liability under applicable laws or regulations or that otherwise may be in conflict with these Terms of Use and our Privacy Policy [<https://members.protec17.org/privacy-policy/>].

- Be likely to deceive any person.
- Promote any illegal activity, or advocate, promote, or assist any unlawful act.
- Cause annoyance, inconvenience, or needless anxiety or be likely to upset, embarrass, alarm, or annoy any other person.
- Impersonate any person, or misrepresent your identity or affiliation with any person or organization.
- Involve commercial activities or sales, such as contests, sweepstakes, and other sales promotions, barter, or advertising.
- Give the impression that they emanate from or are endorsed by the union or any other person or entity, if this is not the case.

Prohibited Uses

You may use the Website only for lawful purposes and in accordance with these Terms of Use. You agree not to use the Website:

- In any way that violates any applicable federal, state, local, or international law or regulation (including, without limitation, any laws regarding the export of data or software to and from the US or other countries).
- For the purpose of exploiting, harming, or attempting to exploit or harm minors in any way by exposing them to inappropriate content, asking for personally identifiable information, or otherwise.
- To send, knowingly receive, upload, download, use, or re-use any material that does not comply with the Content Standards, PROTEC17 Engagement & Community Rules, and Discussion Group Etiquette set out in these Terms of Use.
- To transmit, or procure the sending of, any advertising or promotional material without our prior written consent, including any "junk mail," "chain letter," "spam," or any other similar solicitation.
- To impersonate or attempt to impersonate PROTEC17, a PROTEC17 employee, another user, or any other person or entity.

- To engage in any other conduct that restricts or inhibits anyone's use or enjoyment of the Website, or which, as determined by us, may harm PROTEC17 or users of the Website, or expose them to liability.

Additionally, you agree not to:

- Use the Website in any manner that could disable, overburden, damage, or impair the site or interfere with any other party's use of the Website, including their ability to engage in real time activities through the Website.
- Use any robot, spider, or other automatic device, process, or means to access the Website for any purpose, including monitoring or copying any of the material on the Website.
